

**\$50K MEGA RAFFLE**  
**Terms & Conditions**

**1. Promoter**

The St George Venues' \$50K Mega Raffle will be conducted by St George Leagues Club via its nominee, Daily Press. The benefitting organisation is St George Leagues Club (ABN 77 000 151 020), a not-for-profit organisation. The Raffle will be conducted under Art Union Authority Number GOCAU/2697.

**2. Raffle Promotion Period**

The raffle opens at 9:00am AEST on Thursday 30 April 2026 and closes at 7:00pm AEST on Sunday 28 June 2026. No entries will be accepted after this time.

**3. Raffle Website**

**4. Relevant State and Eligibility**

Entry is open to residents of New South Wales aged 18 years or older at the commencement of the raffle. Residents of any other State or Territory are not permitted to purchase tickets in the raffle and are not eligible for any prizes.

**5. Entry Restrictions**

The following people are not eligible to enter and are not eligible for any prizes:

- (a) members of the management committee of the organisation conducting or benefitting from the raffle;
- (b) employees and contractors of RaffleTix;
- (c) employees of St George Venues, including St George Leagues Club, Scots Club and St George Maso's Club;
- (d) any other person directly engaged in managing the raffle or conducting the draw; and

The following entities are also not eligible to enter and are not eligible for any prizes:

- (a) the organisation conducting the raffle; and
- (b) the organisation benefitting from the raffle.

**6. Verification Requirements**

If requested by the Promoter, a person drawn as the winner of a prize must produce proof of age and residency before being awarded a prize. If they do not do so promptly to the reasonable satisfaction of the Promoter, the Promoter may redraw the prize, subject to any regulatory approval required, and that person forfeits any right to claim the prize.

No maximum number of entries applies per participant while the raffle remains open and tickets are available.

Maximum number of tickets available is 500,000.

The draw will be livestreamed on Facebook Live and broadcast across the three St George Venues clubs. The draw will be conducted in accordance with applicable State Government requirements by the Promoter.

### **10. Draw Method**

An electronic draw will be conducted. Prizes will be drawn in ascending order, with the JAC Oasis Ute major prize drawn last.

### **11. Notification and Publication of Winners**

Winners will be contacted by phone and email within 3 business days of the draw. The winners' names will be published on the raffle website and the relevant St George Venues websites within 3 business days of the draw.

### **12. Prize Claim Period**

Winners have 12 months from the draw date to claim their prize and must contact the Promoter to arrange collection or delivery. If you are a winner, you are responsible for your use of the prize, including complying with all applicable laws and any relevant supplier terms and conditions.

**13. Unclaimed or Invalid Prizes**

If a prize is not claimed within the claim period, or if an entry is deemed invalid under these Terms and Conditions, the Promoter reserves the right, subject to any regulatory approval required, to deal with the unclaimed prize in accordance with applicable raffle laws and permit conditions, including by sale of the prize and application of the proceeds for not-for-profit purposes.

**15. Dispute Resolution**

In the event of any dispute, the Promoter will first attempt to resolve the matter directly with the complainant. If a satisfactory outcome cannot be achieved, the Promoter will liaise directly with the relevant State regulatory authority.
